I. DESCRIPTION OF SERVICES: Services shall consist primarily of providing musical entertainment by means of recorded music format. CNY Entertainment hereby agrees to provide Disc Jockey services performed and to be completed at the following venue/event(s):

- Any other reasonable scenario that could impact DJ from performing in a safe and secure manner.
- Any unforeseen emergent situation that results in DJ being unable to safely perform. Note: DJ will make every reasonable attempt to perform services as outlined herein or substitute with reasonable accommodations.
